Local examinations at least every fourth year thereafter. Furthermore, public school boards shall, in as far as local facilities and personnel are available, provide physical examinations for any and all children and teachers at any time, who, in the opinion of the principal, superintendent, health or physical education teacher, nurse, health officer or family doctor, should be given such examination. The Superintendent of Public Instruction is directed to request teacher education institutions to provide both medical and physical examinations for their teachers and students.

2. Beginning not later than the opening of the 1948-49 school year, each public school and each teacher education institution shall start cumulative health records for each child or student enrolled and entering school, such records to be maintained throughout the child's or student's attendance, after which they will be filed as part of the school's permanent record, and be available for transfer. These health records shall be uniform and on forms prescribed by the Superintendent of Public Instruction. Health data shall be recorded and recommendations sent to both the parents and county health committee or council, if any exist; follow-up checks shall be made of each case by proper health or school authority and results recorded.

3. Beginning not later than the opening of the school year 1948-49, Health and Physical Education shall be included in each pupil's program of study and daily learning in the school. A specific course in basic health shall be required of each pupil in the upper four years of high school. This course should be taken preferably during the ninth or tenth year.

4. No elementary or high school shall be considered as having met health and physical education standards of approval until programs have been put into operation which meet the minimum standards prescribed by the State Board of Education as approved and published in its specified bulletins, syllabi, and courses of study.

BY THE
Governor

Kentucky

To All to Whom These Presents Shall Come:

Whereas, the Kentucky Field Army of the American Cancer Society is engaged in a program of education, service and research to protect the health of the public against cancer; and, Whereas, cancer is the second cause of death in the United States, killing more than 180,000 annually; and, Whereas, the preservation of health is fundamental to the welfare of the state; and, Whereas, the Kentucky Field Army will conduct throughout the month of April its twelfth annual Enlistment Campaign to obtain funds with which to carry on the fight against this dread disease;

a settlement in the spreading strike over pensions for miners. The operators said they would be there—with the men they chose in the first place.

Lewis himself set the hour, but in the same communication to the operators he said the presence of Patents and Humphreys would be "essential to constitute good faith." He refused an operator bid to a 4 p.m. meeting Tuesday without the two men.

The operators in their letter told Lewis: "It is not within your province or authority to choose the persons who represent the coal operators in collective bargaining. It is the operators' responsibility to select their bargaining representatives."

Lewis said Fairless and Humphreys "more than anyone else are qualified to interpret" the contract for their part in its negotiation. Their presence is "essential to constitute good faith," he asserted.

The judge directed his order at both the United Mine Workers which Lewis heads and the soft coal operators which Lewis heads. He said down for three weeks in a pension fund dispute.

4. The union and the operators to engage in free collective bargaining and to "act in good faith" with the view of ending the present dispute over the miners' pension at the earliest possible time."

5. The union and the operators to carry out a provision in their contract which says both sides shall fully cooperate with each other to develop policies for the effective operation of the welfare and retirement fund.

The order says the strike, if permitted to continue, will impair the national health and safety.

Defective evening mechanisms were responsible for 53 accidents taking seven lives and 28 accidents, two of them fatal, resulted from punctured or slow-inflating tires.

Smith said this year's checkup showed also that in 55 cases of fatal accidents the drivers had been drinking and were obviously drunk and that 13 fatal accidents occurred when drivers fell asleep at the wheel.

Out-of-state drivers were involved in 87 fatal accidents and drivers in 37 fatal accidents were found to be operating their cars without drivers' licenses.

ROAD MISHAPS TOTAL 4,913

In State Last Year
With 561 Fatalities;
Accident Causes Cited

Frankfort, Ky., April 5 (Sp.)—At least three-fourths of all Kentucky traffic accidents last year were caused by some sort of traffic violation and the greatest cause of accidents was excessive speed, T. B. Smith, safety director, Kentucky Department of Highways, said today.

In a prepared report on 1947 traffic accidents Smith said his office had received accounts of 4,913 traffic accidents occurring during the year on Kentucky highways, 483 of them fatal.

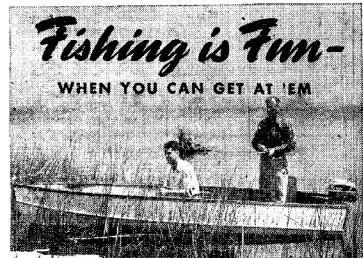

1949 TO SEE PLANT READY

Inland Steel Report Predicts Left Beaver Project Completion

With the demand for cold rolled steel sheets still acute, Inland Steel Company is pushing its program to modernize and increase the capacity of its sheet and strip mills at Indian Harbor. The program, which has been subject to repeated setbacks in the delivery of necessary equipment, is expected to be completed during the latter part of 1948, giving the company an increase of approximately 300,000 tons a year in its output of cold rolled products.

It was reported that during the year Inland continued its efforts to strengthen its raw materials position to support expanded operations at Indian Harbor. In its coal operations, the company began the development of the large acreage acquired in 1946, and is undertaking construction of a large waste and reclamation plant on this property located in what is to be known as Price on Left Beaver Creek. When completed this plant will handle the entire output of the present Wheelwright mine, as well as that of the recently acquired acreage. The entire project is expected to be completed late in 1949.

In their annual report to Inland's stockholders, April 1, Edward L. Ryerson, chairman, and Clifford Sykes, president, explained that a major part of the company's \$16,188,713 expenditure in 1947 for new plants and equipment was in connection with its modernization plant for sheet and strip mills. The program includes the installation of additional finishing equipment, the speeding up of existing equipment, and the reequipping of processing facilities.

Reopening of the Bristol mine, a reserve iron ore property on the Menominee Range at Crystal Falls, Mich., was started late in 1947. It is expected to resume shipments early in 1949.

Negotiations toward the leasing of a large acreage in the Thompson district in Kentucky were concluded during 1947, and exploration of these lands is currently under way. The report pointed out that steel operations are continuing at high level and demand is still in excess of the industry's ability to produce. During 1947 Inland operated at an average rate of 97 per cent of rated capacity, as compared with 82.7 per cent rated capacity in 1946. The steel industry as a whole operated at a rate of 92.9 per cent and 72.5 per cent in 1947 and 1946, respectively.

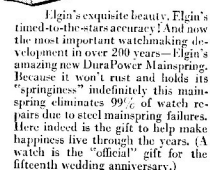

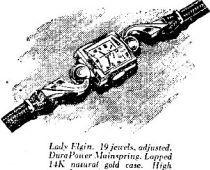

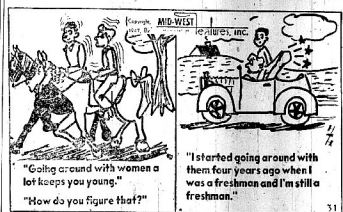

ROAD REPAIR PLANS ISSUED

Floyd Roads Damaged; Four Routes Selected For Initial Attention

Extensive plans for repairing winter highway damage were issued last week to district engineers and maintenance supervisors by the Department of Highways. A grouping of damaged highways to prepare for complete resurfacing by contract in order to facilitate early completion was requested.

U.S. 23 at the upper limits of Prestonsburg, a large section of the Left Beaver highway, and the road from Lackey to Wayland are in miserable condition.

"First consideration must be given the heavily traveled roads with emergency repairs until such time as the weather will permit permanent paving," Commissioner Garrett L. Withers said. "Designs are now being prepared and major work will be let to contract just as soon as the roads are dry enough to warrant. We will use our own facilities as far as is practicable, but the damage is so wide-spread and extensive that the contract method is being employed."

A report from the Division of Maintenance indicates that sections of U.S. 25, U.S. 50, U.S. 41 and KY. 80 were subjected to the greatest damage and will be included in the first group to be repaired by contract. "Field checks on several other heavily traveled routes are being made now," Mr. P. Johnson, director of the Maintenance Division, said. "Every effort will be made to get resurfacing under contract. In the meantime, temporary repairs will be made to make travel just as safe as possible."
