## Police standoff ends in deadly blaze

### Middle Creek man had guns, baited police

MIDDLE CREEK — A Prestonsburg man died last week after allegedly refusing to leave his burning home during an altercation with police.

The body of Phillip Anthony Horn, 58, was removed from the burned home after firefighters extinguished the flames on April 22. According to reports, the

firefighters were afraid to battle the blaze due to fear of being fired at by Horn, who was armed and threatening officers who had arrived at the scene.

"Mr. Horn told officers he wanted them to kill him and then set his home on fire," said Trooper Mike Goble, spokesman for the Kentucky

State Police. "Mr. Horn had told neighbors that he wanted to kill himself and burn his home, and tried to borrow a handgun from his neighbor after having an emergency protective order served against him and approximately 20 firearms taken from his possession by Floyd County deputy sheriffs."

According to Goble, officers believed they heard a shot from inside the home.

"Firefighters at the scene feared being shot at by Horn due to Horn's threats, and officers first on the scene heard Horn fire what they believed was a gunshot inside the residence," Goble said. "After the fire was extinguished, a body

believed to be Mr. Horn was recovered by the Middle Creek Fire Department."

An autopsy has been scheduled to find out the official cause of Horn's death, and the incident is currently under investigation by Kentucky State Police Detective Ben Cramer and Floyd County Deputy Coroner Chuck Hall. Memorial services for Horn were conducted yesterday at Hall Funeral Home in Martin.

PIKEVILLE, KY — State Representative Keith Hall told the Pike County Fiscal Court he has asked the Kentucky General Assembly to consider a bill concerning an ATV trail that would cover several counties in Kentucky.

House bill 173 calls for the establishment of the Kentucky Mountain Trail Corporation (KMTCC) as an independent corporation, attached to the Kentucky Tourism, Arts and Heritage Cabinet, to manage the system. Trails could be over 2,000 miles long. Much of the land for the system is property that has previously been strip mined, and so has much of the groundwork already accomplished.

The bill was passed by the House, but Hall said the bill is currently "stuck in the quagmire of the Senate."

"They did not want to pass it because of fees associated with it," Hall said. "The Senate is not cognizant of how it works, that in a trail system you sell passes, and those fees fund the trail, run the trail."

PRESTONSBURG — Over 170 volunteers spanned the hills at Stone Crest on Friday to plant over 3,000 tree seedlings for Arbor Day.



PRESTONSBURG — During a regularly scheduled meeting of the Prestonsburg City Council Monday evening, city leaders agreed to an extension of contract to their local cable provider.

Suddenlink, the current provider, was given a single term agreement for seven more years to provide cable for city residents.

The provisions of the

agreement, according to the resolution passed during Monday's meeting, have no changes in terms. The extension is not to exceed 10 years, the resolution stipulated.

Also during the meeting, Tim Cooley, captain of the Floyd County Emergency and Rescue Squad, announced to those in attendance that his squad is now officially a nationally certified swift water rescue team.

The significance for the rescue squad, as well

as the city, according to Cooley, is that as a state certified organization he and his men can now play host to surrounding squads he is sure will now visit Prestonsburg for their certification training.

In the past, squads such as Cooley's were forced to travel out of state to receive the training.

The next regularly scheduled meeting of the Prestonsburg City Council is set for May 10.


maintain an escrow account or line of credit that names the Kentucky Department of Fish and Wildlife as the beneficiary to maintain or reclaim the land to its natural state if the county doesn't do the work itself. In the agreement, \$25,000 is listed as the amount. The Kentucky Department of Fish and Wildlife had originally asked for \$50,000 to do the repairs if necessary, but the court voted against that amount.

Also at the meeting, the court voted to accept and assign funding for the House Bill 410 Project at Allen Central High School. The bill provides coal severance money to the Floyd County Board of Education, but

a mistake caused the funds to be transferred to the administration of the fiscal court. The court voted to accept and transfer \$50,000 to the Floyd County Board of Education from House Bill 410.

Julie Roger Webb presented the court with a check for \$25,000. The money was a reimbursement for medical expenses incurred by inmates at the jail.

Friday's meeting also marked the first meeting for new District 2 Magistrate Hattie Owens, who was appointed last week to the position formerly held by her late husband, Jackie Edford Owens. Owens was active in the meeting, making or seconding many of the motions.

## Amendment 1

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; abridging the freedom of speech, or of the press; or the right of the people to peaceably assemble, and to petition the government for a redress of grievances.

### Lack of state budget at this point alarming

in•com•pe•tent, adj. not competent; lacking qualification or ability; incapable

The above definition could surely and adequately describe Kentucky's legislative leadership and how they have behaved in regard to the recent breakdown of state budget negotiations, for certainly they are not capable of working together, and therefore incompetent at their jobs.

Gov. Steve Beshear told reporters last week that he and 10 people off the street could have resolved these budget issues in mere minutes, where the Commonwealth's legislative leaders have failed to do so in a matter of three months. And the governor is probably correct.

The level of our disappointment that a new two-year state budget was not sent to the governor's desk before the General Assembly adjourned last week cannot be adequately put into words. Suffice it to say that Rep. Greg Stumbo and Sen. David Williams have let Kentucky down, and now the taxpayers will be forced to pick up the tab on a special session as a result — to the tune of about \$60,000 per day. Inexcusable.

Speaker Stumbo quickly sent a statement to media outlets following Thursday's breakdown, saying he thought the legislature would move ahead with a one year continuation budget.

"This is a stunning development that flies in the face of all that I thought we had agreed upon," Stumbo said last Thursday. "House and Senate leaders and our staffs were working late last night on getting the final agreements, giving me every indication they were acting in good faith."

Not good enough. We realize these are trying times, but to fail to come to a compromise, and then blame it all on the other guy just doesn't cut it. Compromise should work both ways.

And that goes for Senate President David Williams as well. You can't compromise by allowing the other person to submit all of the recessions. It should be give and take, not take and take.

But now that we've cried over the spilled milk, there is still a job to be done before July 1. Gov. Beshear will most likely call the special session in May. What's say you do your job this time around. You don't have to agree on everything all the time, but you can at least do your job from time to time.

Hall said 18 eastern Kentucky counties have signed up to become part of the trail system, which would, when completed, connect to the Hatfield-McCoy system in West Virginia as well as extend into Virginia, affording riders the opportunity to ride in three states on one trail system, a unique experience.

Studies show the system could potentially attract 200,000 tourists to the area annually. Pike is working with 13 other counties in Kentucky, including Floyd, Johnson, Perry and Wolfe. Pike Judge Executive Wayne T. Rutherford said he felt the system would be a great success and that the county was moving forward with plans for the trail system as though the bill had passed.

Hall said he hopes the bill will be considered in a special session of the legislature.





SOMERSET — It was a busy weekend for the Prestonsburg High School track and field program as the PHS boys' and girls' teams competed in the Lake Cumberland Classic at Somerset. Both PHS track and field teams (boys and girls) finished eighth out of 15 teams. PHS competed in its third invitational meet in its many weeks.

Prestonsburg started out on the long trip to Pulaski County before dawn on Saturday morning.

The Prestonsburg girls' team was short-handed due to some competitors at a dance competition and others sick. Still, Prestonsburg managed to finish eighth on the girls' side.

The 4x800 relay team (Jette Burchett, Masana Potter, Makayla Williamson, McKenzie Collins) turned in its second-best effort of the year with a time of 14:38.74, placing seventh.

The 4x200 relay team of Leanna Goble, Courtney Foley, Alli Hopkins and Tinchler finished seventh in 2:08.17.

Makayla Williamson ran a personal record time of 3:30.58 for a 10th-place finish in the 1600.

Jette Burchett, Foley, Alessandra Lamolinara and Hopkins ran a season-best time in the 4x100 relay event. The time of 1:01.45 gave the team a seventh-place finish.

Goble continued to run well in the 300-meter hurdles. Her time of 59.69 gave her a seventh-place finish. She finished seventh despite tripping and falling following the last hurdle.

Mckenzie Collins ran her second best time in the 800 meter run. The time of 3:16.63 put her in 14th place.

As in the 100-meter dash, both girls in the 200-meter produced personal records. Tinchler had a time of 29.39 (under 30 seconds for the first time), finishing 10th. Foley ran a 33.45 for a 17th-place finish.

Hopkins had a pair of 11th place finishes in the shot put and discus — 17'09" (shot put) and 46'10" (discus), respectively.

Two Prestonsburg girls scored in the long jump. Goble was fourth with a jump of 12'00". Foley finished seventh with a jump of 11'01".

On the boys' side for Prestonsburg, Joseph Jamerson placed first in the 110-meter hurdles with a time of 15.80.

In the 100-meter dash, Cameron Tinchler ran to a seventh-place finish with a time of

## Tyler Newsome signs with Pikeville College

PIKEVILLE — Some think of him as the shooter. Others say him as overlooked. Some thought him quiet. In the end, all saw him as one thing: Champion.

Now, they'll all call Tyler Newsome something else: Pikeville College Bear.

Newsome signed a scholarship agreement with Pikeville on Monday morning in a ceremony held at Shelby Valley High School, the place he helped bring three state championships in his time wearing a Wildcat uniform.

"We're very pleased Tyler has decided to join us at Pikeville College," said Coach Kelly Wells. "He has a lot of talent and obviously knows how to win. Even more importantly, he wanted to be a Bear. We're thrilled we

could help all this work out."

Newsome, whose father Greg was the orange and black, scored 965 points and pulled 422 rebounds in his career at Shelby Valley. In addition, he had 192 assists, 154 steals and blocked 33 shots.

As a senior, he averaged 12.4 points and 5.5 rebounds for the Wildcats, who went 32-4 while becoming the first team in the history of Kentucky high school basketball to win both the Sweet 16 and the All "A" Classic state titles in the same season.

Newsome made 45.4 percent of his field goal attempts in his career and made 96 three-point shots, leaving him only three shy of Kris Bentley's school record. He was also a 71.2 percent shooter from the free throw line.

Newsome became the

third of Shelby Valley's eight seniors to sign scholarships with Pikeville College. The other two, Dillon Tackett and Tanner Tackett, will play football for the Bears.

Andy Southard (3-2) took the loss after allowing 11 runs — five earned — on nine hits in 5 2/3 innings.



## UK standouts Lindley, Conner headed north in the NFL

**LEXINGTON** — University of Kentucky cornerback Trevard Lindley and fullback John Conner will be headed north in order to fulfill their goal of playing in the National Football League.

Lindley was chosen by the Philadelphia Eagles in the fourth round, the 105th overall pick, and Conner was tabbed by the New York Jets in the fifth round, 139th overall, as the NFL Draft wrapped up Saturday.

Lindley and Conner join defensive tackle Corey Peters (third round, Atlanta) as UK's selections in the draft. Additional Wildcatters are expected to sign as free agents. A total of 17 Kentucky players have signed NFL contracts over the past two seasons.

Lindley was a four-year starter for the Wildcats, totaling 189 tackles, 10 interceptions and a school-record 43 pass breakups during his career.

Game-changing plays were the hallmark of his days as a Wildcat, as seven of his 10 interceptions were key plays in Kentucky victories and another pick helped send a game to overtime. He scored three touchdowns in his career — a 66-yard punt return at Arkansas (2007) and interception returns for TDs against South Carolina (2008) and Miami of Ohio (2009).

Lindley earned accolades every season of his career, including first-team Freshman All-America in 2006, third-team All-America and consensus first-team All-Southeastern Conference as a junior and second-team All-SEC as a senior. Lindley was named the nation's best cornerback prior to his senior season by Lindy's college football magazine, but a high-ankle sprain derailed his final campaign, forcing him to miss four games and playing his last five at less than full

speed.

Lindley has completed his degree in art studio. Born in Ludika Springs, Ga., he came to UK from Hiram (Ga.) High School.

Conner has been the team's starting fullback since his sophomore season. Primarily used as a blocker, Conner developed a reputation as a devastating negator of defenders and outstanding special teams performer. He was named the SEC's "Best Blocking Back" in the Birmingham News prior to his senior season.

Conner also was quite effective when called upon to run or catch the ball. During his career he rushed 54 times for 247 yards and four touchdowns. His average of 4.6 yards per carry is an excellent figure for a fullback. He caught 25 passes for 147 yards, an 8.1 average, and four TDs as a Wildcat.

Conner, a native of Cincinnati, Ohio, completed his UK degree in kinesiology.

## Spawning season is upon us — and time for some great fishing

**FRANKFORT** — Crappie spawn when the dogwoods bloom, the old saying goes. The white bass run when the redbuds burst out in spring. Old, grizzled anglers claim they can smell when the bluegill spawn in a pond.

These old sayings about when fish move shallow to reproduce aren't too far off the mark. The jury is still out on whether anglers can smell bluegill in a pond, but knowing when certain species spawn helps anglers improve their skills.

"Those sayings are actually a pretty good rule of thumb regarding air and water temperature," said Benji Kinman, deputy commissioner of the Kentucky Department of Fish and Wildlife Resources. "The most important aspects are water temperature and the lengthening days. The longer days are critical."

A crappie study in Missouri demonstrated Kinman's wisdom. The study found crappie began building nests when daylight starts to average a little over 13 hours. Crappie put building nests when the sunlight lasts slightly longer than 14 1/2 hours a day. This corresponds with crappie initiating the spawn when water temperatures reach the low 60s and continuing until it reaches the low 70s.

Many Kentucky reservoirs are now in that temperature range. Black crappie are in the shallows at Kentucky and Cave Run lakes, preparing to spawn. White crappie are nosing their way around the shallows at Green River Lake.

In the future, time your crappie trips to match sunlight of 13 to 14 hours a day with water temperatures in the 60s. This should put you right in the middle of the spawn.

The redbuds are in full bloom and anglers will find white bass staging in the headwaters of Barren River, Herrington, Taylorsville, Green River, Lake Barkley and other lakes in Kentucky. White bass first begin migrating to the headwaters of reservoirs and toward locks and dams on the Kentucky and Ohio rivers when the water temperatures reach 50 degrees. When water temperatures hit the high 50s to low 60s, the white bass spawning runs begin. White bass in runs provide some of the best fishing in Kentucky.

White bass spawn in moving water by dropping their sticky eggs in shallow water on a hard bottom. One female white bass can release as many as 500,000 eggs. White bass abandon their eggs and provide no parental care to their young. The abandonment triggers poor reproductive success.

Water temperatures vary widely throughout the state right now. Anglers report recently catching a mixed bag of hybrid striped bass and white bass at Herrington Lake. White bass are now running in the headwaters of Barren River Lake.

A good rain and increased flow into these lakes would further increase the white bass run. Check the fishing reports on Kentucky Fish and Wildlife's Web site at [fwky.gov](http://fwky.gov) for the status of the white bass runs.

As spring melts into May, the bluegill and redear sunfish, also known as "shellcrackers," move toward the banks. In ponds and lakes, bluegill spawn in such shallow areas that anglers can easily see their whitish hubcap-sized nests.

Bluegill and redear sunfish start making nests when water temperatures reach 70 degrees. They may spawn all the way into mid-June.

Redear sunfish spawn around the edges of weedbeds once water temperatures reach 62 degrees. Spawning stops once the water warms to 68 degrees.

"Redear spawn a little earlier than bluegill," said Gerry Buynak, assistant director of fisheries for Kentucky Fish and Wildlife. "They should be getting interested right now."

Bluegill can't resist white, yellow or black feather Popeye-style jigs tipped with a wax worm cast under a bobber and worked just over their nests. Redear sunfish devour the same rig cast along weed-lines.

A small, yellow, curly-tailed grub also works well for these fish. The next six weeks is the best time of the year to fish for bluegill and redear sunfish.

Crappie, white bass, bluegill and redear sunfish are making their spawning moves right now. It's time to take advantage of the best fishing of the year.

Deadline to apply for elk hunt approaching: Just a few days remain before the April 30 deadline to apply for Kentucky's 2010 elk hunt.

With a traditional 90 percent success rate among bull elk hunters and a low application fee of \$10 for one of the 800 quota hunt permits being issued this year, thousands of hunters from across the United States are expected to register in the coming days. Kentucky's elk herd numbers approximately 10,000.

"It's a real excitement among hunters about Kentucky elk," said Kentucky Fish and Wildlife Commissioner Jon Gassett. "We issue more than twice as many elk permits as the rest of the eastern United States combined. This is the chance of a lifetime."

Kentucky accepts online applications only through its Web site, [fwky.gov](http://fwky.gov). The drawing is open to residents and non-residents. Last year, more than 46,000 people from every state in the country applied for a Kentucky elk hunt, including 28 from Alaska and one from Hawaii.

"People don't realize how exceptional Kentucky elk hunting is coming into it," said Karen Waldrop, wildlife director for the Kentucky Department of Fish and Wildlife Resources. "Afterwards, they tell me the hunt far exceeded their expectations."

Kentucky's modern elk herd is the result of a major restoration program that began with the release of seven elk from Kansas in December 1997. More than 1,500 elk from seven states were released into Kentucky's mountain and crossbow hunters. The restoration project ended in 2002.

Kentucky's elk have a diverse genetic mix due to the varying sources used for the original transplants.

"A recent genetic study shows that Kentucky elk tend to be a bit bigger as far as body weight than their western counterparts," said Tina Brunjes, Kentucky Fish and Wildlife's big game program coordinator. "Kentucky's mild winters and long growing season are working well for elk."

The good news for hunters wishing to fill their freezers with meat: Kentucky will issue 600 cow elk permits this year. The state will also issue 125 permits for mature bull elk and 75 permits for spike bulls through its quota hunt drawing this year.

As the elk herd ages, Kentucky's record for a bull with non-typical antlers falls nearly every year. The current record is a 7x7 bull taken off public land last October. That bull scored 372 6/8 in the Boone and Crockett Club scoring system.

Kentucky's record typical elk — which received a 371 Boone and Crockett Club score — was taken in 2007. Brunjes believes that mark is ripe to fall. "I think we're due for a new state record typical bull this year," she said.

Although the majority of elk are taken off private property, Brunjes noted 236 elk were harvested last year from the 150,000 acres of land open to public hunting within southeastern Kentucky's 16-county elk restoration zone. Kentucky's hunter success rate for cows and bulls is 84 percent, she added.

Hunters have until midnight (Eastern time) April 30 for the chance to win the hunt of a lifetime — an elk hunt in Kentucky. Visit [fwky.gov](http://fwky.gov) online to apply for a hunt or to learn more about elk hunting in Kentucky.

Firearms seasons for bulls include separate one-week seasons from Oct. 2-8 and Oct. 9-15, while the one-week firearms seasons for cow elk are Dec. 11-17 and Dec. 18-24. Extended seasons exist for bow and crossbow hunters. The department also has a special youth season from Sept. 25-27.

"If you get drawn for a permit," Brunjes said, "your odds of getting an elk are very good."

## Building a healthy future for your child

How do you define "healthy"? Perhaps more importantly, how do you know if your child is healthy? I'm not talking about whether your youngster has a cold or allergies or anything obvious like that. I'm talking about the child's basic build — whether he or she is on the slight side, or tends more toward what used to be called "chunky." Sometimes, just a glance seems to tell the story, but the answer isn't always that obvious.

In the previous century (in other words, when I was a kid), every doctor had those old insurance company height-and-weight charts hanging in the office to depress us all. More recently, it's been all about BMI — your Body Mass Index. That's a calculation that's also based on your height and weight, and the National Heart, Lung and Blood Institute, part of the National Institutes of Health, has a simple one on-line at <http://www.nhlbiisupport.com/bmi/>.

If your BMI turns out to be between 18.5 and 24.9, pat yourself on the back; you're at a healthy weight. If your BMI is 25 to 29.9, you're overweight, and a BMI of 30 or more indicates obesity.

There are limitations to the BMI's accuracy, unfortunately. For example, it can overestimate the BMI for athletes who have a very muscular build. Another good way to gauge yourself is by measuring your waist; that's a good indicator of your abdominal fat. Anything over 40 inches for men or 35 inches for women could indicate a higher risk for developing risk factors for heart disease and other health problems.

But scientists funded by the Agricultural Research Service (ARS) are coming up with even better, more sophisticated ways to calculate how much lean (that's bone, muscle and water) and body fat is healthy and normal for youngsters as they grow from babies to teens.

The secret, it seems, is ... gamma rays.

This may sound like an idea straight out of "Plan 9 from Outer Space," but it's perfectly legitimate. It's actually healthy and natural for human beings to emit gamma rays. At the ARS Children's Nutrition Research Center at Baylor College of Medicine in Houston, Texas, a gamma ray device known as "whole body gamma counter" is one of about a half-dozen complex instruments that are used for the specialized job of determining body fat and lean, known collectively as "body composition."

The idea is to bring all these tools together to produce a new generation of "body comp charts" that could become as much a fixture as the BMI charts or height-and-weight charts now in pediatricians' offices. These new tables would give parents and medical professionals an improved way to determine how a particular child's growth pattern compares with that of healthy, fit youngsters of the child's age, height, weight, gender and ethnic background.

Speaking of background, there's a lot to creating this type of body-comp chart. The researchers have to find and fine-tune the best technologies for acquiring thousands of measurements from many healthy young volunteers, and then analyze those measurements to create the charts.

That work has taken well over a decade, but the research team says it's now only about two years away from issuing the preliminary body-comp tables based on data from normal, fit black, white and Hispanic youngsters in the Houston area.

Still wondering about those gamma rays? Here's how they fit into the equation. Gamma rays are emitted by potassium, and most of the potassium in your body is in the muscles. So this means the specialists can use gamma ray measurements to develop an indi-

rect, but accurate, measure of your body's muscle mass. Overall, the new body-comp charts will replace and improve on existing tables that don't take into account today's ethnic diversity, are based on data derived from older technologies, and could have other major drawbacks.

The ARS-funded researchers in Houston have already made major contributions to our knowledge about youngsters' health, such as determining how many calories a child needs at various stages of growth. These new body-comp charts will be an important tool for parents and medical professionals alike in helping today's youngsters get a good start on building a healthy body to serve them well for a lifetime.

## Ten Years Ago

(April 23, 26, 28 2000)

The Wheelwright Commission meeting turned into a debate, Thursday night, as Lowell Parker and commission members argued the merits of paying a portion of the utility bill for a group of agencies that will bring county services to Wheelwright and Left Beaver. Carol Holbrook of the Floyd County Health Department, Don Sparkman from Community Based Services, Larry Paul Hall from McDowell Appalachian Regional Hospital and David Bliss from Mountain Community Hospital came before the commission requesting help with utility bills for the various organizations. Even though everyone concerned with the exercise said the bill was not connected in any way to the Columbine tragedy, the staged events at Prestonsburg Community College yesterday were reminiscent of the high school shooting one year ago in Colorado. Even though calls were tagged with "this is a drill," the situation seemed tense and chaotic as calls for help went out to the different agencies. For the last 15 years, area leaders of Floyd, Johnson, Martin, Magoffin and Pike counties have seen Roger Recktenwald head up a team of dedicated workers, constantly trying to make the Big Sandy Region a better place to live. Water and sewer, industrial development, flood control, and better city budgeting have come underneath his direction. Randall Lee Shepherd, 22, of Brushy Fork Road, was killed Friday afternoon, after he lost control of his car and crashed into a guardrail. He was traveling on Rt. 7, in Hueysville, when the passenger-side tires of his vehicle slipped off the road onto the shoulder. Of several pieces of legislation voted by Patton, the legislature voted to override the governor's veto on House Bill 70, which exempts religious organizations from some of the state's civil rights laws, was overridden in the House on a vote of 82-16. The Senate override vote was 26-8. An apparent shootout between Ernest E. "Bucky" Collins, 46, and Henry Clifton, 49, both of Prestonsburg, ended with one dead and one turning himself over to the local police, Easter Sunday. Operating water and sewer systems all over the United States, USF promises quick expansion and growth for the new network. Police are searching for clues to an armed robbery which happened early yesterday morning in the Pike County community of Mota. A masked gunman entered the Mota Mart at 5:05 a.m., armed with a shotgun and demanded money from the cashier, as well as two customers who were inside the store at the time. He then fled the store with an undetermined amount of money, escaping with an accomplice in a red Chevy Cavalier. Three days after being shot to death by his wife on the front porch of their Toler home, John Bush was victimized once again, this time as three Michigan teenagers allegedly attempted to rob his grave to take his head. As many as 40 local workers will be affected by Jacksonville-based Winn Dixie Stores Inc.'s decision to close 22 stores in Kentucky, Tennessee, Ohio and Indiana between May 27 and June 24.
